- 1) The buyer accepts the responsibility for caring for the kitten/cat and providing for its welfare . The kitten/cat will be kept as an indoor pet.
- 2) The buyer agrees that the kitten/cat will receive medical care if and when necessary. The buyer agrees not to declaw the kitten/cat. If buyer declaws kitten/cat, all health guarantees, return/refund covenants of this contract are NULL AND VOID.
- 3) All purchase payments and any applicable shipping charges will be prepaid by the buyer before the kitten/cat is transferred to buyer.
- 4) Deposits are non-refundable unless seller agrees otherwise.
- 5) No kitten/cat may be returned for health reasons unless examined by a licensed veterinarian at the buyer's expense. This exam must take place within 72 business hours after seller delivers kitten/cat to buyer. The veterinarian must supply a written statement of the diagnosis to include symptoms observed. The seller has the right to a second opinion from a veterinarian of seller's choice. Kitten/cat returned under the conditions of this paragraph may be replaced by the seller with a kitten/cat of equal quality as soon as one becomes available or a refund of the purchase price may occur at the seller's discretion. This paragraph and covenant is null and void if any evidence of negligence is present; sarcomas develop as a result of vaccinations given while in buyer's possession including rabies and feline leukemia.
- 6) If the kitten/cat dies within one year of delivery, a necropsy needs to be conducted by a licensed veterinarian pathologist at the buyer's expense. Seller will be contacted about the death within 24 hours. If the death is determined to be the result of a genetic defect, such as PKD, or HCM, evidenced by the necropsy, the kitten/cat will be replaced per Paragraph 5.
- 7) Seller will not be held responsible for any veterinarian bills after kitten/cat is delivered to buyer.
- 8) This kitten/cat is being purchased for the purpose of (pet, breeder, show).

9) This kitten/cat has had (3) kitten shots commencing 8 weeks and intervals of 4 weeks thereafter. . The vaccine used was Ft. Dodge Killed 3 in 1 (two upper respiratory and panleukopenia (feline distemper). The seller strongly recommends not giving either rabies or Feline Leukemia vaccines as they have a history of developing lymphoma sarcomas at injection site which results in cancer and eventually death. After one year of age if leukemia negative, they are immune to leukemia. See paragraph 5.

As respects the care of a male kitten/cat approaching 8 months of age, seller strongly recommends adding to kitten/cat's diet, Hill's dry C/D to maintain proper urinary balance and as a preventative of urinary tract conditions and/or complications. This kitten/cat has been on a dry diet including Kirkland (Costco), Nutro Max Adult Roasted Chicken, Authority (PetSmart).

The litter used is 2/3rds Wal-Mart Premium (yellow bag) and 1/3 Scoop Away Clumping (Costco). The kitten/cat is not used to covered litterboxes. Highly scented litter such as Fresh Step can cause skin and sinus allergies.
